- b) Park Jefferson LLC and Riverside Boutique & Consignment submitted a site plan application to open a retail boutique and change the signage at 4881 N. Jefferson. The store will sell mostly women's clothing, have 1-3 employees, and be open seasonally Thursday through Sunday 10:00 AM 4:00 PM. The Board reviewed the application and Parts 2 and 3 of the SEQR. David Rockwell made the motion to determine a negative declaration. Josh Menio seconded the motion, and it passed 5-0. The motion to accept the application as complete was made by Kimberly Bedient seconded the motion, and it passed with all in favor.
- c) John Parker of 4811 Salina Street, LLC submitted an application for a special use permit and a site plan application to put up a 24-unit self-storage building at 3734 State Route 13. The units are not permanent. The Board reviewed the application and Parts 2 and 3 of the SEQR. Josh Menio made the motion to determine a negative declaration with a second from Ernie Wheeler. The motion passed with all in favor. There will be a public hearing Tuesday, September 2, 2025, at 7:00 PM.
