Services will be held at 6:30 PM on Thursdays and 10:30 AM on Sundays. The building will require a fire inspection before services are held. The Board reviewed the site plan

and parts 2 & 3 of the SEQR. David Rockwell made the motion to determine a negative declaration on the SEQR assessment form. Josh Menio seconded the motion, and it passed with all in favor. The motion to approve the site plan application was made by David Rockwell and seconded by Josh Menio. The motion passed unanimously.
